Commissioner Banks introduced guests, Cpl Braden Stephenson of Kings District RCMP, Minister of Health and local MLA Leo Glavine and Auditor Lawrence Lake.

Commissioner Banks then turned the floor over to Cpl Stephenson of the Kings District RCMP. Cpl Stephenson spoke to those assembled about the priorities of Kings District RCMP over the past year and the types of calls being received in Greenwood.

#### 2020-2021 OPERATING AND CAPITAL BUDGET

The Village of Greenwood 2020-2021 Operating and Capital Budget was circulated. Clerk-Treasurer Lynn Moar presented the hi-lights of the budget. There were no questions from the electorate.

## **ELECTION OF COMMISSIONERS**

Nomination Day was held on October 7th, 2020. There were two nominations received for two positions. Both nominees were acclaimed by the Returning Officer and were sworn in at the regular meeting of the Village Commission held on October 21, 2020. Commissioner Bob Baker will serve for another three years and Commissioner Dale Harty will fill the vacancy left by the resignation of long time Commissioner Don MacDonald. That term will be open for election in 2021.

#### TEMPORARY BORROWING RESOLUTION

Chair Brian Banks recognized Commissioner Sealby who put forward the following motion to the electorate:

Commissioner Sealby: "I move the adoption of the resolution to borrow One Hundred and Ninety Five Thousand Dollars for the construction of a sidewalk on Rocknotch Road as distributed to the electorate present here today."

The motion was seconded by Don MacDonald.

Commissioner Banks asked for discussion from the floor. There were no questions asked or discussion.

Chairman Banks: "Hearing no other debate, the question is on the adoption of the resolution as distributed, which if adopted, would direct that one hundred and ninety five thousand dollars be borrowed under the terms described in the resolution for the construction of a sidewalk on Rocknotch Road. All those in favour, please raise you hand to be counted."

There were 14 hands raised in favour of the motion

Chairman Banks: "All those against, please raise your hand"

There were no hands raised opposing the motion

The motion was CARRIED.

Commissioner Sealby took the floor to update the electorate regarding the 2017 Accessibility Act, the terms of which must be implemented by 2030.
